The Functions are:

- (1) To receive Application /Appeal Petition and acknowledge them with date on such requests.

- (3) To scrutinize Applications /Appeal Petitions and find out concerned section to whom request is to be forwarded to concerned Department.
- (4) To put up the file to the concerned Secretary for submission of replies if the queries are replicable in his capacity.
- (5) To assist Appellate Authority as and when required.
