Subject: Declaration of cut-off-date: Assam Solar Project

This is to inform you that Assam Power Distribution Company Limited (APDCL) will be developing a 1000MW(750 MWac) Solar Power Plant at Lahorijan under the Diphu Revenue Circle in the Karbi Anglong District covering part of seven villages such as (i) Lahorijan, (ii) Khatkhathi, (iii) Borlengrijan, (iv) Karagaon, (v) Longkathar, (vi) Lalmati and Nahorjan.

Karbi Anglong Autonomous Council (KAAC) will be allocating land to APDCL for developing the Solar Project for which land acquisition will be done by the KAAC. In order to provide the land, KAAC has undertaken land acquisition and resettlement impacts in terms of loss of land of the customary land owners, loss of structures, loss of crops, trees etc. Also, assessment has been done for the impact on tenants.

In, this regard, the land and revenue department of KAAC hereby declares this date "25/09/2024", as the cut-off date for eligibility and entitlement of affected people to the compensation. Any Persons reported after this cut-off-date will not be eligible for receiving any compensation and Resettlement and Rehabilitation (R&R) assistance.
