The Council Development Committee (CDC) meeting was held under the chairmanship of Sri Mukul Kr. Saikia, IAS, Principal Secretary, Karbi Anglong Autonomous Council, Diphu. The primary objective of the meeting was to assess the current status of various developmental schemes and ensure timely redressal of pending issues that require immediate attention.

The matters discussed in the meeting and the decisions taken during the meeting are as follows:

**AG Audit reply and reconciliation of accounts:**

1. The Sr. Financial Adviser, Finance (Budget) Department, KAAC presented a Powerpoint on AG audit replies, focusing on the departmental pending liabilities and outstanding audit paras.
2. The Sr. FA, Finance (Budget) Department, KAAC was instructed to hold review meeting with the HoDs and their assistants regarding AG audit replies.
3. The Principal Secretary, KAAC directed all departments to clear their pending liabilities without delay.
4. All departments were instructed to draft replies to audit observations and submit them to the Sr. FA, Finance (Budget) Department, KAAC. Audit replies should be submitted by May 2025.
5. All departments were instructed to submit Utilization Certificate (UC) for the first half of FY 2024-25 immediately.

**Review of Flagship Programs :**

A comprehensive review of ongoing flagship programs was undertaken. The committee expressed satisfaction with the progress of some schemes but directed improvement in areas lagging behind.

**Preparation of Report for Hon'ble CM's Review Meeting :**

The Principal Secretary apprised about the proposed visit of Hon'ble Chief Minister's to Karbi Anglong from 17<sup>th</sup> April' 2025 to 19<sup>th</sup> April' 2025. He also apprised that the Chief Minister will inaugurate all completed roads and will hold a review meeting with the HoDs and all officials of KAAC. In this regard, departments were directed to submit comprehensive reports on Prime Minister, Chief Minister's initiative Flagship Programmes along with beneficiary – oriented schemes. Report should submit high quality photographs with appropriate captions.

### **Rationalization of Schools :**

1. The Principal Secretary discussed the need for rationalization of schools based on student enrolment and teacher availability. He asked the Inspector of Schools to provide a report on the rationalization of schools.
2. Matter regarding poor performance of Schools of Karbi Anglong and West Karbi Anglong Districts in Gunotsav was discussed and advised to treat every day as a Gunotsav day and work accordingly to improve performance.

### **Revenue Collection :**

The Principal Secretary instructed all departments to submit a report on current revenue collection status within 10<sup>th</sup> April'2025.

Moreover,

- Departments were directed to submit proposals on revenue-generating schemes aimed at economic upliftment.
- The Joint Director of Handloom & Textiles was instructed to take the necessary initiative to obtain a Geographical Indication (GI) tag for Karbi Attire.
- Regarding the matter related to Smart Meter, Principal Secretary apprised the Official of APDCL that matter will be discussed in the upcoming Executive Committee (EC) meeting.

The meeting concluded with a vote of thanks from the Chair and an appeal for proactive and timely action on all discussed matters.
