NOTICE INVITING TENDER (RE-TENDER)

In partial continuation of the earlier NIT issued on 25th July 2025 vide no. KAAC/TAX/Bamboo/NIT/2025/8062 (III)/32 effect of which only one (01) bid had been received for **Phuloni Revenue Circle** which is deemed insufficient as per extant norms, a fresh sealed tenders are re-invited from eligible individuals who are permanent residents of Karbi Anglong & West Karbi Anglong, cooperatives registered under KAAC and agencies whose principal place of business is within Karbi Anglong & West Karbi Anglong districts as per enclosed format by the Department of Taxation, Karbi Anglong Autonomous Council (KAAC), for appointment of **Bamboo Distributors for Phuloni Revenue Circle** for regulation of home-grown and cultivated bamboo extraction and supply sourced from all revenue and non-forest village areas within the aforementioned circle.

Brief of the Tender:


1. The successful bidder will be issued a **Bamboo Distributorship Licence** by the Department of Taxation, KAAC, for Phuloni circle within Karbi Anglong District.
 2. The selected bidder shall deposit a **one-time settlement fee** which will be as per the tendered value. The base value of the bids is fixed at Rs. 20,00,000 (Rupees Twenty Lakhs) for Phuloni Revenue Circle.
 3. The bamboo distributors shall be liable to pay a Green Cess @ Rs. 2/- per bamboo pole. Serialized transit challans mentioning the number of bamboo poles/pieces and green cess receipts will be issued by the Department of Environment and Forest, KAAC.
 4. An Earnest Money Deposit (EMD) of Rs. 5,00,000 (Rupees Five Lakhs only) @25% of the base value shall be deposited by the bidders. This EMD shall be forfeited by the selected bidders in case of the winning bid amount not being deposited to the KAAC Exchequer within 7 (Seven) working days from the date of the final settlement order.
 5. It will be the responsibility of the successful bidder to ensure the scientific harvesting of bamboo.
 6. This tender does not cover wild grown species of Bamboo like Kako, Dalu, Khang, Kaligoda and Muli.
 7. The **initial term** of the distributorship will be **24 months**, extendable by another **24 months** based on mutual agreement between the KAAC authority and the incumbent distributors.
 8. The appointed distributors shall have exclusive rights to purchase cultivated and homegrown bamboo poles sourced from revenue and non-forest lands within **Phuloni Circle for supply purposes** and shall establish **depots** along national and state highways for collection and further sale. A **detailed Standard Operating Procedure (SOP)** shall be issued by the Department of Taxation, KAAC in due course in this regard.
 9. Buyers from **outside KAAC territory** shall procure bamboo only from these designated depots and **Transit Challans** mentioning quantity, origin depot, and destination, will be verified at the **Entry Tax Gates (ETGs)** upon exit by the Department of Taxation, KAAC.

5. The bidder must deposit the earnest money in favour of **THE DEPUTY SECRETARY, DEPARTMENT OF TAXATION, KAAC** through a bank demand draft.
